This deed of public charitable trust executed in Delhi on this 03rd day of October 2018 by:




WHEREAS the following persons are trustees in Trust for the purposes detailed in this Trust Deed:


Whereas the Founders of the trust are desirous of creating a public charitable trust with a motive to serve the society at large by child development, preventing health issues, promoting yoga and Empowering all sections of the society through providing basic and higher education and skills to develop competencies to make them self-sufficient, self-reliant and economically stable to lead a normal life without any motive to make any profit or to have any other form of gain by doing so. These objects and purposes are expressed in this trust deed under clause 3 of this deed.



- To propagate, impart and adopt any audio-visual methods for education and awareness and help in the inculcation of such behavior as would bring happiness to mankind without reservation of status, caste and religion.
- To promote family planning and Health awareness to improve life style, medical care and other social values for better care of citizen of India particularly in rural area. To spread education - cum motivational efforts with quality family planning, mother and child health services across nation.
- To initiate, promote and implement research, advocacy capacity building and any others related activity, so as to strengthen the public healthcare system.
- To work towards promoting and enhancing the credibility and integrity of the institutions of public health.
- To undertake welfare activities and awareness program on Child / women's Health & Nutrition.
- To spread Family Planning information, counseling and services to women for healthy reproduction through various programmes.
- To educate women about safe delivery and post-delivery of the mother and the baby and the treatment of women before pregnancy.
- To provide Health care for infant's immunization against preventable diseases by setting up various health care centers across nation.
- To spread awareness about Prevention and treatment of sexually and Reproductive Tract infection.
- To arrange and organize Camps for eye, blood donation, routine health checkups, Diabetes, Obesity and for various other diseases across nation.
- To provide information and education, useful knowledge and the medical advice to general public about the dangerous diseases of HIV/AIDS, etc through holding awareness camps and lectures by expert teams of doctor & professionals.
- To open centers, institutes for diagnostic curative and research of HIV/AIDS and other related diseases.
- To Promote Ayurveda and other ancient system of medicine namely Unani Naturopathy etc. in the country by setting up various research centers Vaidyashalas, hospitals etc.
- To provide financial assistance/ scholarships to Researchers/Scholars their contribution as well as to help them conduct their research work further in their respective field of Medicines.
- To run, establish various Institutes, Collages, University of repute in field of Ayurvedic research & education, Naturopathy, Siddha, Unani, Homeopathy etc. To open & promote Herbal Parks, cultivation of medicinal plants in agriculture, organic farming, preservation of endangered species herbs, plants & trees across nation.
- To publish Books, Charts, illustrations, Journals, Magazines, periodicals News Letters/papers and other publications on the different subjects as



- different languages for the promotion of above Aims and objects or the above trust.
- To approach the concerned authority/authorities regarding the solution of the problems of the members of the trust.
 - To assist and co-operate the other Association, Societies, Trusts in their work/activities whose aims are same like this trust.
 - trust will invest its money and funds according to section 11(5) of the income Tax Act of 1961.
 - To receive financial and non-financial assistance from Govt./Non-Government organization, international bodies, Bank, Company' and any other legal entity or individual for attainment the objective of the organization and to fulfill the needs of the people.
 - To accept donations, grant presents, gifts and other offerings in the shape of movable and immovable properties and the same shall be utilized for the promotion of Aims objects of the above trust.
 - To make survey for collection of data for the attainment of any objects of the trust.
 - To collect notices, notifications, policies, information from the Govt., Semi-Govt., NGO and other National/International agencies and provide the same to the members of the trust and the general public.
 - The aims and objects of the trust shall be purely for 'CHARITABLE PURPOSE' which includes relief of the poor, educational, social, medical relief and the advancement of any other objects of general public utility.
 - To erect, construct, alter, maintain improve, develop, manage and control all or any part of the property or the building of the above trust, necessary or convenient for the purpose of the attainment of the aims and object of the trust.
 - To purchase/acquire the land and/or building in the name of the trust for the upliftment and fulfillment of the aims and objects of the trust.
 - To do such other things /acts/activities which are necessary and which may be incidental or conducive to the attainment of any of the object of the trust.
 - All the incomes, earnings, movable / immovable properties of the trust shall be solely utilized and applied towards the promotion of its aims and object only a set forth in the Memorandum of the trust and no profit, thereof shall be paid or transferred directly or indirectly by way of dividends, bonus, profits or in any other manner whatsoever to the present or past members of the trust or to any person claiming through any one or more of the present or the past members. No member of the trust shall have any personal claim on any moveable or immovable properties of the trust or make any profits, whatsoever, by virtue of this membership.



- To carry on certificate courses relating to aforesaid objects and also providing placement for the same.
 - To organize lectures, seminars and workshop to help or strengthen the requirements of needy persons.
 - To raise awareness among all classes of society with the help of exhibition, movies, meeting, speech etc. for fulfillment of the aims and objectives of the society.
 - Organizing and providing education and training in one or more aspects of carpet and textiles technology and such disciplines and subjects and such other areas as may suitably be combined with the courses of study and training of the Institute and as thought fit.
 - To work for the welfare of socially neglected people and to protest and fight against the Injustice against people.
 - To give best possible teaching and training to its students, so they can easily serve in society effectively and with dignity.
 - To arrange part time classes for working needy personnel such as an electrical, mechanical, Refrigeration, Air conditioning, interior designing, computer education, Medical classes, health care centers etc.
 - To provide job oriented and professional education having highest job potential in various Government and non-Government institutions and organizations.
 - To promote and popularized education under informal education system on pattern of Board, open school and universities of other countries.
 - By offering need based primary, secondary, higher secondary, technical, vocational, management and paramedical education courses.
 - To invite the different educational organizations including schools, colleges, institutes, deemed universities, universities, film production houses, media production houses, magazines, websites & social media campaign etc.
 - To identify children from under privileged backgrounds and provide free basic education to them.
 - To provide proper development and prepare underprivileged children for formal schooling, making them less likely to drop out at a later stage.
 - To provide the best education available in some of the best schools of the Nation, Emphasis would be on character building, self-discipline and the development of the creative and social facilities: The Trust aims at producing well informed and well assured young people just the kind of Citizen that our country needs.
 - To provide vocational educational at its own or in association with other agencies/institutions in the welfare of the students by introducing some special beneficial schemes for the rural candidates, schedule caste, schedule tribes and other backward classes.
- To establish, maintain, administer education institution for imparting general, technical, medical, scientific mechanical, social, art, commercial and any other kind of education for the youth irrespective of cast, creed and gender.
